Rules of the 10km Run during the DOZ Marathon Łódź 2024 Event

The content of these Terms and Conditions is valid from 23 January 2024.

The 10km run (hereinafter: Run) takes place as part of the event called DOZ Marathon Łódź 2024 (hereinafter: Event).

I. Organiser, Performer and Partners of the Run.

1. Organiser

Association "Maraton Dbam o Zdrowie" with its registered office in Łódź, ul. Zbąszyńska 3, 91-342 Łódź, registered in the Register of Associations, Other Social and Professional Organisations, Foundations and Independent Public Health Care Facilities run by the District Court for Łódź-Śródmieście in Łódź Commercial Court XX Commercial Division of the National Register Court Register under KRS number 0000403717, REGON: 101325327, NIP: 9471980735.

2. Contractor:

Ms. Joanna Chmiel running a business under the name Beauty Sport Run Joanna Chmiel with its registered office in Łódź at ul. Konstadta 7 m. 66, 91-430 Łódź, NIP 7271445611, REGON 364956765.

The Organiser entrusts the Contractor with the implementation of the event under the name "DOZ Maraton Łódź 2024" together with accompanying events on 26-28 April 2024, in particular the 10 km Run.

II. Goal of the Run

The aim of the Run is:

- popularisation of running as the simplest form of physical activity among adults and schoolchildren,
- promoting sport among different social, environmental and professional groups;
- promoting sport in the family,
- promotion of the City of Łódź and the Łódź region in Poland and around the world.

III. Name, date, place of the Run

Name: DOZ Maraton Łódź – 10km Run

Date: 28 April 2024 (Sunday)

Place: Łódź, Atlas Arena, Al. Bandurskiego 7 (start, finish, running office)

Start: 9:00 a. m.

Finish: Atlas Arena, Al. Bandurskiego 7, Łódź

IV. Route of the Run

- 1. The route of the race has a certificate and marking of every kilometre, made by the certifying entity licensed by the Polish Athletics Association.
- 2. The run will be supervised by the judges of the Polish Athletics Association (PZLA).

V. Rules of participation in the Run

- 1. There is a limit of 3,500 entries and a time limit of 1 hour 30 minutes.
- 2. The time limit referred to in point 1 above will be verified by the Organiser from 5 km according to the timetable: 5km 45:00"; 6km 54:00"; 7km 1:03:00"; 8km 1:12. 00"; 9km 1:21,00".
- 3. Exceeding the time limit at a given measuring point results in informing the Participant about this fact and the order to leave the route of the Run.
- 4. After the time limit of 1 hour 30 minutes. traffic on the running route is restored.
- 5. Any person who in 2024 will be at least 16 years old may become a participant of the Run. Participation in the Run of persons who are under 18 years of age requires consent of parents or legal guardians in writing on pain of nullity.
- 6. The consent form will be available at www.lodzmaraton.pl under the tab "Dokumenty do pobrania" ("Documents for download").
- 7. The condition of participation in the Run is to register electronically on the website www.lodzmaraton.pl until April 27, 2024 or in person at the office of the April 26-27, 2024 (as long as the registration limit is not exhausted), as well as payment of the entry fee until April 27, 2024, in accordance with the price list indicated in point VIII, section 5 of this Regulation.
- 8. Failure to pay the entry fee referred to in point VIII of these Regulations results in failure to assign a bib number to the Participant and inability to participate in the Run.
- 9. Only Participants whose participation has been paid and with assigned bib numbers have the right to start in the Run.
- 10. On the day of the Run (April 28, 2024), registration will not be possible. That day the competition office of the Run will only issue numbers and starting packages to previously registered participants whose share has been paid for.
- 11. Any changes in applications made electronically (among others, change of names, rewriting of package to another person) will not be made after April 10, 2024.
- 12. A participant who registered for the Run, but did not pay the fee by 9:00 p.m. on April 27, 2024 is deregistered.
- 13. Each Participant must pick up the number and the starting package on 26-28 April 2024 at the office of running competitions. The condition for collecting the bib number and the package is to show the QR code sent by the registration company to the e-mail address of the participant, which was presented during registration in the application form. QR code you need to show at the competition office on the phone or have printed.
- 14. If it is not possible to personally collect the number and starting package, the Participant may authorise another person to present the QR code referred to in point 13 above.
- 15. In the case of a minor participant of the Run, the collection of the package and the bib number will be only possible with the written consent of the parent or legal guardian. Print for the parent's statement or legal guardian will be available for download at www.lodzmaraton.pl in the 'Documents for download'.
- 16. Each participant of the Run must run with a bib number assigned by the Organiser placed in a visible position at the front.
- 17. During the Run, each Run Participant must have a bib number attached horizontally to the front of the shirt (or the outer cover). The bib number must be visible throughout the duration of the run.
- 18. Covering the number (in whole or in part, during any part of the Run) or modifying it is prohibited under penalty of disqualification.
- 19. Adults take part in the Run at their own risk, being aware of their current state of health. The Organiser recommends the Run Participants to conduct tests in connection with the intention to participate in the Run and not to register to participate in the Running in case of medical contraindications. Participant submits to participate in the Run on their own risk and your own responsibility. The Organiser is not responsible for the consequences of participation in the Run of participants whose health condition is a contraindication to participate in the Run. The Organiser does not verify the health of the Participants. Responsibility for the start and health of minors are borne by their parents or legal guardians.
- 20. Providing the Organiser with a properly completed application form and entry fee, as well as consent to the participation of a minor means that the participant/guardian considers and assess the nature, extent and degree of risk associated with participation in the Run, including risk of accidents, the possibility of injury and physical injury, including death as well as property damage and voluntarily decided to take this risk.

- 21. Participants running with a child in a stroller are required to line up at the end of the SELECTED LAUNCH ZONE! It is forbidden to set and take off at the beginning of the start zone.
- 22. Participants are obliged to run only on the route indicated by the Organiser.
- **23.** Participants are obliged to comply strictly during the competition to the orders of the municipal services, i. e. the Police, the Municipal Guard, the MPK Traffic Supervision and the order of the Organiser and judges and other services securing the route of the Run.

The participants of the Run are absolutely obliged to allow the passage of privileged vehicles being in action (riding on the signal) - under penalty of disqualification.

- 24. Decisions of medical service regarding the continuation of the Run by the Participant who has been the aid granted is final and indisputable.
- 25. Receiving the bib number and joining the Run is equivalent to getting acquainted with the rules of the Run and the obligation to comply with its provisions.
- 26. Numbers and starting packages will be issued at the Run Event Office. Run Event Office will be located in the Hall under the stand of the Municipal Stadium. Władysław Król at Aleja Unii Lubelskiej 2 in Łódź entrance from Atlas Arena and will be open on the following days and hours:
 - 26 April 2024 (Friday) from 13:00 to 20:00
 - 27 April 2024 (Saturday) from 11:00 to 21:00
 - 28 April 2024 (Sunday) 7:00-15:30, with starter packages only be issued until 8:30 a. m. on that day.
- 27. On the day of the Run, i. e. 28 April 2024, registration for the Run will not be conducted. That day you will only be able to pick up the package and bib number.
- 28. The deposit will be open on 28 April 2024 from 7:00 a. m. on the premises of the Atlas Arena at Al. Bandurskiego 7 in Łódź. Failure to collect the deposit by the Run Participant until 16:00 causes the forfeiture of this deposit and enables the Organiser to dispose of it.
- 29. Participation in the Run of a disabled person in a wheelchair requires prior consent of the organiser. Participants moving on sports wheelchairs will not be allowed to the Run with Rim-push type direct drive and handbike type indirect drive. Disabled persons allowed to participate in the Run by the Organiser will be classified within the Open category.
- 30. Assistance to a Participant provided by a bystander during the run along the entire length of the route (including buffet points) is not allowed and will result in disgualification.
- 31. On the running route, except for Participants with bib numbers, there may be only persons designated by the Organiser moving by car, bicycle or on foot appropriately marked and having an identification tag.
- 32. It is forbidden to move along the entire length of the route for the people on bicycles, scooters and other locomotive equipment without the permission of the Organiser.
- 33. A competitor next to whom a bystander is riding a bicycle, scooter or other locomotion device will be disqualified by the judge. Disqualification is given by the referee of the competition by showing the disqualified competitor a red card and providing information about the reason for disqualification. Final disqualification must be preceded by a warning given by the referee to the competitor concerned by showing a yellow card and verbally stating the reason for the warning.
- 34. After disqualification, the competitor is obliged to leave the route.

VI. Running categories and classifications

- 1. The following categories and classifications will be conducted as part of the Run:
 - OPEN category of women and men
 - Age categories of women and men

W/M - 16 16 - 19 years old

W/M - 20 20 - 29 years old

 $W/M-30\ 30-39\ years\ old$

W/M - 40 40 - 49 years old

W/M-5050-59 years old

W/M - 60 60 - 69 years old

W/M - 70 + 70 years and more

- 2. Age categories and OPEN categories do not duplicate.
- 3. The basis of classification is electronic timing based on an electronic chip located in the bib number. The participant who will lose the bib number or will not bring it to the finish line of the Run, will not be classified. On the route of the Run there will be control mats that record the appearance of the Participant at a given point. Lack of the appearance of a Run Participant at a particular point shall disqualify the Run Participant.

VII. Entries to the Run

- 1. When applying, the Participant must indicate what result they plan to achieve at the finish line or the current result achieved at a given distance.
- 2. Participants will be assigned bib numbers with the indication of the time zone at the start, in which the Participant will be required to line up.
- 3. The start will take place separately for each zone every 1 minute.
- 4. Participants are obliged to comply with the instructions of the Organiser and the security services.
- 5. Launch zones:
 - Zone I result below 40' yellow
 - Zone II result 40:00"-45:00" green
 - Zone III result 45:01"-50:00" red
 - Zone IV result 50:01"-55:00" blue
 - Zone V result 55:01"-60:00" orange
 - Zone VI result above 60' grey
- 6. For the first 50. Participants, results at the finish line will be measured according to gross time, that is the time from the moment of the start to the moment the finish line is crossed. For all other participants of the Run will be taken into account the net time obtained by the Participant, is the time counted from the crossing of the start line to the crossing of the finish line.
- 7. The limit of entries in the Run is 3500 people.
- 8. If the limit of applications referred to in paragraph 7 above is exhausted by 27 April 2024. The Organiser reserves the right to increase this limit. Information about an increase in the application limit will be posted on the website www.lodzmaraton.pl
- 9. The Participant registered for the Run shall be deemed to be the one who has registered by filling out the form application on the website www.lodzmaraton.pl, accepted it and sent the application, and subsequently paid starting fee.
- 10. The entry fee made by the Participant is not refundable if the Participant will give up the start! It is also prohibited to transfer and resell bib number to another person without the consent of the Organiser! The fee is refundable only in exceptional and justified cases at the request of the participant.

VIII. Entry fees for participation in the Run

- The entry fee includes all costs related to the organisation of the DOZ Marathon and costs for elements necessary to participate in the Marathon, i. e. elements of the starting package listed in point XI, paragraph 1 of the Rules of Procedure. Entry fee for participation in the Run in connection with registration electronic payment should be made electronically via the "Proceed to payment" option available from the level of the application form.
- 2. Entry fees for participants who will register to participate in the Run at the office 26-27 April 2024 (subject to availability) will be paid for **only in cash. It will not be possible to pay by card.**
- 3. As part of the fees for participation in the Run made online via the form registration available via the website www.lodzmaraton.pl The Organiser allows Participants of credit card payments.
- 4. The Run Participant, who wants to receive an invoice for the entry fee, is obliged to provide precise personal data in the application form or in the office of the Run. If you do not provide data for the invoice or provided data will be incomplete, the invoice will not be issued. The invoice is issued by the Organiser.
- 5. Amounts of entry fees:
 - 1st term payment made by 14 January 2024 PLN 69
 - 2nd term payment made on 15 January 2024 14 February 2024 PLN 89

- 3rd term payment made between 15 February 2024 25 April 2024 PLN 129
- 4th term-payment made at the Run competition office on 26-27 April 2024 PLN 180
- 6. The proof of receipt of the fee is the appearance of the starting number next to the name of the Participant on the start list on the website www.lodzmaraton.pl.
- 7. If after 7 (seven) days the starting number does not appear, the Participant is obliged to contact the Organiser by e-mail: stowarzyszenie@pelion.eu
- 8. The fee once paid is not refundable or transferable to another Participant or another course organised by the Organiser, subject to point XIII point 25 of these Regulations.
- 9. Exemption from the starting fee in the Run is granted to persons born in 1954 or older.
- 10. Exemption from the entry fee for persons referred to in paragraph 9 above shall be granted only in the case of registration for the Online Run by filling out the application form available at www.lodzmaraton.pl. It does not apply to registration for Run in the Run Event office on 26-27 April 2024.
- 11. In order to benefit from the exemption from the entry fee, the participant of the Run referred to in paragraph 9 above should register for the Run by filling out the application form available at website www.lodzmaraton.pl by 27 April 2024, excluding payment option.
- 12. The Organiser has the right to exempt selected Participants from the entry fee in random situations, as well as other Run Participants at their own discretion.
- 13. The Organiser does not provide for a possibility of anonymous start.

IX. Deposits and meals

- 1. Participants of the Run will receive a deposit bag with a place to enter the bib number, allowing you to deposit things in a specially designated place. The bag can only be picked up on the basis of the bib number. In case of loss by Run participant's bib number, the Organiser is exempt from responsibility for collecting bag by another person. It is forbidden to leave in the deposit:
 - a. valuables,
 - b. things that due to their properties may be broken, flooded or crushed,
 - c. documents.

For leaving in the deposit the things specified in letters a - c above, the Organiser shall not bear responsibility.

2. The deposit will be open on 16 April 2024 from 7:00 a. m. to 4:00 p. m.

Items left in the deposit and not collected by 16:00 will not be sent back to Run Participants In such case, the Organiser has the right to dispose of them.

3. Before the Run, the Participants will have the opportunity to use the changing room. After the Run Participants will have the opportunity to use the changing room, massage and showers.

All Run Participants receive: the opportunity to use the refresh point on the run route and a restorative meal at the finish line.

4. On the day of the Run, toilets will be available to Run Participants in the area in front of Atlas Arena.

X. Running Prizes

Detailed information on the prizes in all categories of the Run will be published in the "Awards" tab on the website www.lodzmaraton.pl no later than 10 April 2024.

XI. Starting package

- **1.** Each Run Participant receives in the package: bib number, pins, gifts and gadgets from sponsors, regenerative meal after the Run, result on mobile phone (in case of informing the Organiser about the phone number).
- 2. Each Participant who completes the Run will receive a commemorative medal at the finish line.
- **3.** The Organiser provides one water buffet point on the route of the Run for about 5 km of the route.
- **4.** The Organiser does not accept private nutrients/bottles from Run Participants.
- 5. With the receipt of the Starting Package, each Run Participant receives a technical shirt.
- 6. Uncollected within the period specified in these Regulations Package and technical shirt subject to forfeiture.

XII. Personal data

- 1. The administrator of personal data provided in connection with the registration of participation in the Run is Association "Maraton Dbam o Zdrowie", ul. Zbąszyńska 3 91-342 Łódź.
- 2. The legal bases and the duration of the processing of your data for individual purposes are as follows:

- 3. The data of no more than the first 10 Participants in each category may be processed by period up to 3 years from the end of the Event.
- 4. After the end of the processing, the data will be anonymized in terms of the name and surname.
- 5. Providing personal data and image in connection with the purpose, which is the performance of the linking parties to the contract (accepted terms and conditions), is voluntary, but necessary to register participation and to start in the Run. For other purposes, i. e. sending information about offers and marketing in the case of sending them electronically providing personal data is voluntary.
- 6. The data will be transferred to entities cooperating in the organisation of the Event, and if they express your consent, also to sponsors, whose current list is available on the website www.lodzmaraton.pl.
- 7. You have the right to request access to your personal data, their rectification, deletion or restriction of processing, as well as the right to object to processing and the right to transfer your data and lodge a complaint with the supervisory authority President of the Office Protection of Personal

- Data, whereby the request to delete personal data is equivalent to removal from the list of participants of the Run.
- 8. You have the right to submit a declaration of withdrawal of consent to the processing given by your personal data at any time by sending a letter or electronic, according to your choice. Withdrawal of consent does not affect compliance with the right to data processing, which was made on the basis of consent before its withdrawal.
- 9. Providing personal data is voluntary, but necessary to register your participation and to start in the Run.
- 10. Your data will be transferred to entities cooperating in the organisation of the Event and Run and if you agree, also to Sponsors and Partners. Current list of Sponsors and Partners can be found at www.lodzmaraton.pl. The list will be updated on an ongoing basis, your acknowledge and agreement.
- 11. Your personal data will be processed until a possible revocation by your consent, and then for the period necessary to secure any claims related with data processing.
- 12. Your personal data will not be processed for the purpose of automated decisions, including profiling.
- 13. Your personal data will not be transferred to a third country or international organisation.
- 14. In matters concerning the processing of personal data, please contact us at association@pelion.eu

XIII. Final Provisions

- 1. The race will take place regardless of weather conditions.
- 2. The Organiser provides medical care during the race on the route and at the finish line.
- 3. The organiser is covered by third party liability insurance. The event, including the Run, is covered by liability insurance and accident insurance, any claims in this regard should be addressed to the Organiser. Organiser does not provide participants with life insurance, health insurance or civil liability for sickness, accident, injury, death or losses that may occur in connection with participation in the Run.
- 4. The organiser suggests that participants purchase an individual accident insurance.
- 5. The results of the Run will be available immediately after the Run on the website www.datasport.pl and the website www.lodzmaraton.pl.
- 6. Each Participant is obliged to wear a bib number during the Run.
- 7. Running time limit is 1 hour 30 minutes.
- 8. Participants are obliged to run only on the route designated by the organiser.
- 9. Participants are obliged to submit during the Run to the orders of the city services, i. e. Police, City Guard, MPK Traffic Supervision and the organiser's law enforcement services. Participants of the Run are obliged to allow vehicles to travel privileged being in action (riding on the signal) under penalty of disqualification.
- 10. Participants remaining on the route of the Run after the indicated time limit, do so on their own risk and liability, in accordance with traffic regulations and the Civil Code.
- 11. Participants of the Run are bound by the regulations of the Polish Athletics Association available on the website www.pzla.pl and these Terms and Conditions.
- 12. Participants shortening or changing the route of the Run will be disqualified.
- 13. Timekeeping is electronic with chips placed on the inside of the bib number.
- 14. A Run participant who shortens the route and misses the timed points will not be classified.
- 15. Protests and complaints will be accepted in writing up to 30 minutes after the end of the Run in the office of running competition. Protests and complaints will be considered up to 3 (three) days after the end of the Run. After this time the results of the Run become official results.
- 16. During the Run and accompanying events a photographic report and video will be taken. During registration, participants agree to the use of the image and processing personal data. Failure to give consent will prevent registration and participation in the Run.
- 17. The Organiser reserves the right and the Participant agrees to carry out with each interview participants, taking photos and filming for advertising, promotional purposes, use of these materials on the Internet or in radio and television broadcasts and for other commercial needs.
- 18. The Organiser reserves the right and the Participant agrees to use free of charge all over the world of photos, videos, interviews and sound recordings representing the participants of the Run. They may be used by the Organiser by placing on CD, DVD, in catalogs and media, on websites, in newspapers

- and at exhibitions, as well as for promotional and advertising needs related to activities conducted by the Organiser.
- 19. Consent to the processing of the image and personal data on behalf of the minor is expressed by the parent or quardian.
- 20. It is forbidden for Participants, fans and accompanying persons to bring intoxicating, illegal performance-enhancing substances and alcohol to the place of the Run. For Participants it is forbidden to take such means and substances both before and during the Run under the threat of exclusion, exclusion from the Run and disqualification.
- 21. The Organiser is not responsible for things lost during the Run.
- 22. Only Participants with a bib number may be on the route during the Run, the bib number must be placed in a visible place on the chest. Participants without bib numbers and accompanying persons on bicycles, rollerblades, skateboards and other mechanical devices will be removed from the route.
- 23. For safety reasons, it is forbidden to bring on the route, the area around the start and finish of the Run objects that may pose a danger to other Participants or fans and persons accompanying.
- 24. It is forbidden to participate in the Run in clothing that covers the face and prevents identification.
- 25. If the Race is postponed not due to the fault of the Organiser, but due to force majeure, to another date, Participants may start the Run at the specified new date, as part of the paid entry fee. The new date of the Run will be announced no later than in 30 (thirty) days from the date of notification of the need to reschedule the Run. In such case of resignation from the Run and refund of funds is entitled at the request of the Participant in accordance with the rules set out in paragraph 28 below.
- 26. Due to the change in the date of organisation of the Event due to the elections to local government bodies taking place on April 7, 2024, the Participant who has already paid the entry fee has the right to resign from participation in the Run within two weeks from the date of announcing the change in the regulations of the Run date and ask for a refund of the paid entry fee or express your willingness to transfer your participation within the paid entry fee to another distance of the Event organised on the new date. Cancellation from the Run and a refund are available at the Participant's request in accordance with the rules set out in section 28 below. A request to be transferred to another distance (race) is made by sending a transfer request, within the deadline specified in the first sentence, to the e-mail address: kontakt@dozmaraton.pl.
- 27. For the participants of the Run there will be parking (free and paid) access from Al. Unii Lubelskiej in
- 28. The Organiser reserves the right to amend the Regulations no later than April 1, 2024. Any changes to the regulations will be posted on the website with an indication of its initial date of application, no later than 01 April 2024, with at least 14 (fourteen) days in advance. A participant who does not accept the change of the rules has the right to resign from participation in the Run within 14 (fourteen) days from the date of the change. Resignation from participation in the Run with indication of the bank account number for the refund of the fee must be delivered to the address: Stowarzyszenie "Maraton Dbam o Zdrowie", ul. Zbąszyńska 3, 91-342 Łódź or electronically to the following e-mail address: stowarzyszenie@pelion.eu. The Organiser shall return the entry fee to the participant no later than within 14 (fourteen) days from the date of delivery of the participant's declaration of resignation from the Run. Changes purely technical and organisational, including changes to limits, times, number of participants or hours opening of the Running office does not constitute a change of the Regulations entitling to a refund the entry fee paid.
