

## **Rules of the Kids Run during the DOZ Marathon Łódź 2024 Event**

The content of these Terms and Conditions is valid from 23 January 2024.

The Kids Run (hereinafter: Run) takes place as part of the event called DOZ Marathon Łódź 2024 (hereinafter: Event).

### **I. Organiser, Performer and Partners of the Run**

#### **1. Organiser**

Association „Maraton Dbam o Zdrowie” with its registered office in Łódź, ul. Zbąszyńska 3, 91-342 Łódź, registered in the Register of Associations, Other Social and Professional Organisations, Foundations and Independent Public Health Care Facilities run by the District Court for Łódź-Śródmieście in Łódź Commercial Court XX Commercial Division of the National Register Court sRegister under KRS number 0000403717, REGON: 101325327, NIP: 9471980735.

#### **2. Contractor**

Ms. Joanna Chmiel running a business under the name Beauty Sport Run Joanna Chmiel with its registered office in Łódź at ul. Konstadta 7 m. 66, 91-430 Łódź, NIP 7271445611, REGON 364956765.

The Organiser entrusts the Contractor with the implementation of the event under the name „DOZ Maraton Łódź 2024” together with accompanying events on 26-28 April 2024, in particular the Kids Run.

### **II. Goal of the Run**

The goal of the Run is:

- popularisation of running as the simplest form of physical activity among teachers, children and schoolchildren,
- promoting sport among different age, social and environmental groups;
- promoting sport in schools and families;
- promotion of the City of Łódź and the Łódź region in Poland and around the world.

### **III. Name, date and place of the Run**

Name: DOZ Marathon Łódź – Kids Run

Date: 27 April 2024 (Saturday)

Place: The area around Atlas Arena, Władysław Król Municipal Stadium in Lodz (start, finish, competition office).

Start time: from 10:00 am, according to the schedule of the Event

### **IV. Route**

1. The race will take place at different distances depending on the age of the Participants.
2. The course of the Run will be supervised by the judges of the Polish Athletics Association.
3. The route of the Run will be marked in and around the Atlas Arena at Al. Bandurskiego 7 in Łódź.
4. The race route will be published on the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl)

## **V. Conditions of Participation and Schedule of the Run**

1. There is a limit of 70 entries per Run.
2. Race schedule for each age category and the distance of the Run on April 15th 2024:

- 3.** Any person born in a given year may become a Runner, according to the age categories referred to in paragraph 2 above
- 4.** Each Runner must be registered for the Run by a parent or guardian electronically by filling in the application form available on the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl) by 26 April 2024 or in person at the office of the 26 April 2024 (as long as the registration limit is not exhausted)
- 5.** On the day of the Run (April 27, 2024), registration will not be possible. That day the competition office will only issue numbers and starting packages.
- 6.** Any changes to the entries (including name changes) will not be made after April 10th 2024
- 7.** The condition of participation in the Run is to register electronically on the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl) by 26 April 2024 or in person at the competition office on 26 April 2024 (as long as the registration limit is not exhausted), as well as payment of the entry fee, in accordance with the price list referred to in point VI of these Regulations until April 26, 2024 at 8:00 pm.
- 8.** Failure to pay the entry fee referred to in point VI of these Regulations results in failure to assign a bib number to the Participant and inability to participate in the Run.
- 9.** Only Participants with paid participation fee and assigned bib numbers have the right to start in the Run.
- 10.** A parent or guardian of a Participant who has registered a Participant for the Run, but has not paid the entry fee by 8:00 p.m. on April 26, 2024, must take into account that the Participant will be removed from the entry list and the Runner will not be allowed to compete.
- 11.** Each parent or guardian must personally collect the Runner's number and starting package on April 26-27, 2024 at the Run competition office.
- 12.** When receiving the bib number, the parent/guardian must show (on the phone or printed) the QR code assigned to the player and sent to the e-mail address of the guardian/parent specified in the form registration when registering the child. The QR code will also show in the application immediately after the entry fee.
- 13.** If it is not possible to collect the number and the starting package in person, the parent/guardian may authorise an adult proxy and provide him with a QR code of the player.
- 14.** Each Runner must run with a bib number assigned by the Organiser placed in a visible position at the front.
- 15.** During the Run, each Run Participant must have a bib number attached horizontally to the front of the shirt (or the outer cover). The bib number must be visible throughout the duration of the run.
- 16.** Covering the number (in whole or in part, during any part of the Run) or modifying it is prohibited under penalty of disqualification.
- 17.** Parents/guardians take full responsibility for the participation of the child/guardian in the Run, being aware of the current state of health of the child/guardian. The organiser recommends parents/guardians to carry out medical examinations of Run Participants in connection with the intention to participate in the Run and not to register the Participants to participate in the Run in the event of medical contraindications. The Organiser is not responsible for the consequences of participation in the Run Participants whose health condition is a contraindication to participate in the Run. The Organiser does not verify the health of the Participants. Parent/guardian of the Run Participant through his/her registration acknowledges the above and takes full responsibility for the Participant.
- 18.** Providing the Organiser with a properly completed application form, the entry fee and consent to the participation of the minor means that the parent/guardian has considered and assessed the nature, extent and degree of risk associated with the participation of the child/guardian Running, including the risk of accidents, the possibility of injury and physical injuries, including death as well as property damage and voluntarily decided to undertake this risk.
- 19.** Participants of the Run are obliged to run only on the route indicated by the Organiser.
- 20.** Participants of the Run are obliged to submit absolutely during the Run to orders of the municipal services, i. e. the Police, the Municipal Guard, and the Organiser's law enforcement services and judges and other services securing the route of the race.
- 21.** Decisions of medical service regarding the continuation of the run by the Participant who has been granted the aid is final and indisputable.
- 22.** The participation of the Run Participants is the full responsibility of their parents or guardians.

23. Receiving the bib number and joining the Run is equivalent to getting acquainted by the parent/guardian with the rules of the Run and the obligation to comply with its provisions.
24. Packages and bib numbers will be issued at the Race office. The Running Competition Office will be located in Atlas Arena at Al. Bandurskiego 7 in Łódź and will be open on the following days and hours:
- 26 April 2024 (Friday) from 13:00 to 20:00;
  - 27 April 2024 (Saturday) from 8:00 a. m. to 30 minutes before the start of the race. After this time, issuing packages and bib numbers for a given age category of the Run is ended.
25. **On the day of the Run, i. e. April 27, 2024, registration for the Run will not be conducted.**  
**On this day you will only be able to pick up the package and the bib number.**
26. The results of all Runners at the finish line will be calculated according to gross time, i. e. time from the moment the starter is fired to the moment the finish line is crossed.

## VI. Entry fees

1. The entry fee includes all costs related to the organisation of the DOZ Marathon and costs for elements necessary to participate in the Marathon, i. e. elements of the starting package listed in point VII paragraph 1 of the Rules of Procedure. The entry fee for participation in the Run must be paid by electronic via the "Proceed to payment" option available from the application form at [www.lodzmaraton.pl](http://www.lodzmaraton.pl).
2. Entry fees for Participants who will be registered for the Run in the office of the Run on 26 April 2024 (subject to availability) **will be paid in cash. There will not be card payment options.**
3. As part of the fees for participation in the Run made online via the form registration available via the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl) The Organiser allows Participants of credit card payments.
4. Parent/guardian of the Run Participant who wants to receive an invoice for the Run Participant's entry fee, is obliged to provide in the application form accurate data to be issued invoices. In case of failure to provide invoice data or incomplete data, the invoice will not be issued. The invoice is issued by the Organiser.
5. Amounts of entry fees:
  - **1st term – payment made by 25 April 2024 – PLN 39**
  - **2nd term – payment made at the Running Competition Office on 26 April 2024 – 70 PLN**
6. The proof of receipt of the fee is the appearance of the starting number next to the name of the Participant Run on the starting list on the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl).
7. If after 7 (seven) days the starting number does not appear, the parent/guardian of the Run Participant is obliged to contact the Organiser at the following e-mail address: [stowarzyszenie@pelion.eu](mailto:stowarzyszenie@pelion.eu).
8. The fee once paid is not refundable or transferable to another Run Participant or another run organised by the Organiser.
9. The Organiser has the right to exempt selected Run Participants from the starting fee.
10. The entry fee made for the Run Participant is not refundable if the Participant will give up the start! It is also not allowed to transfer and resell the number to another person without the consent of the Organiser! The fee is refundable only in exceptional and justified cases at the request of a participant.
11. The Organiser does not provide for the possibility of anonymous start in the Run.

## VII. Starting Package

1. Each Run Participant receives in the starting package: T-shirt, bib number, pins, gifts and gadgets from sponsors of the Run, water at the finish line, and additionally – in case of agreement by the parent/guardian in the registration form – also the result achieved in the Run, which will be sent to the phone number provided by the parent/guardian in the application form.
2. Each Participant who completes the Run will receive a commemorative medal at the finish line.
3. The Organiser does not accept private nutrients/bottles from Run Participants.

## VIII. Running Prizes

1. Detailed information about the prizes in the Run will be published in the "Prizes" tab at [www.lodzmaraton.pl](http://www.lodzmaraton.pl) no later than 10 April 2024.

## IX. Personal data

1. The administrator of personal data provided in connection with the registration of participation in the Run is Association "Maraton Dbam o Zdrowie", ul. Zbąszyńska 3, 91-342 Łódź.
2. Legal basis and time of processing personal data of the Participant and his/her parent/guardian the specific objectives are as follows:

3. Data of no more than the first 10 Participants in each category of the Run may be processed for a period of up to 3 years from the end of the Event.
4. After the end of the processing, the data will be anonymized in terms of the name and surname.
5. Providing personal data and image in connection with the purpose, which is the performance of the linking The parties to the contract (accepted terms and conditions), is voluntary, but necessary to register participation and to start in the Run. For other purposes, i. e. sending information about offers and marketing in the case of sending them electronically – providing personal data is voluntary.
6. The data will be transferred to entities cooperating in the organisation of the Event, and if the Run Participant's parent/guardian will give his/her consent, also to sponsors whose current list is available at [www.lodzmaraton.pl](http://www.lodzmaraton.pl).
7. The Run Participant's parent/guardian has the right to request access to his/her personal data and personal data of your child/guardian, their rectification, deletion or limitation processing, as well as the right to object to processing and the right to transfer data and lodge a complaint with the supervisory authority - President of the Data Protection Office personal data, whereby a request to delete personal data is tantamount to deleting Run participant from the list of Run and Event participants and the inability to start in the Run.
8. The parent/guardian of the Run Participant has the right to submit a declaration of withdrawal of consent to processing your personal data and your child's or guardian's personal data at any time by sending letter or electronic correspondence, according to of your own choice. Withdrawal of consent does not affect the lawfulness of data processing, which was made on the basis of consent before its withdrawal.

9. Providing personal data is voluntary, but necessary to register participation and to start of the Run Participant in the Run.
10. Personal data of Run Participants and their parents/guardians will be transferred to subjects cooperating in the organisation of the Event and the Run, and if the parent/guardian of the Run Participant gives consent, also to Sponsors and Partners. The current list of Sponsors and Partners can be found at [www.lodzmaraton.pl](http://www.lodzmaraton.pl). The list will be updated which every parent/guardian of the Run Participant acknowledges and agrees.
11. Personal data of Run Participants and their parents/guardians will be processed until possible revocation by the participant's parent/guardian, and then for the period necessary to secure any claims related to data processing.
12. Personal data of Run Participants and their parents/guardians will not be processed for the purpose of automated decision-making, including profiling.
13. Personal data of Run Participants and their parents/guardians will not be transferred to a third country or an international organisation.

## **X. Final Provisions**

1. The race will take place regardless of weather conditions.
  2. The Organiser provides medical care during the race on the route and at the finish line.
  3. The organiser is covered by third party liability insurance. The event, including the Run, is covered by liability insurance and accident insurance, any claims in this regard should be addressed to the Organiser. Organiser does not provide the Participants with life insurance, health insurance or civil liability for sickness, accident, injury, death or losses that may occur in connection with participation in the Run.
  4. The organiser suggests that parents/guardians purchase an individual accident insurance for Participants of the Run.
  5. The results of the Run will be available immediately after the Run on the website [www.datasport.pl](http://www.datasport.pl) and the website [www.lodzmaraton.pl](http://www.lodzmaraton.pl).
  6. Participants of the Run are obliged to wear a bib number during the Run.
  7. Participants of the Run are obliged to run only by the route designated by the Organiser.
  8. The participants of the Run are obliged to submit during the Run to the orders of the services municipal authorities, i. e. the Police, the City Guard and the Organiser's law enforcement services.
  9. Timekeeping during the Run is electronic with chips placed on the inside of the bib number.
  10. A Run Participant who shortens or changes the Run route will be disqualified.
  11. Protests and complaints will be accepted in writing up to 30 minutes after the end of the Run in the office running competitions. Protests and complaints will be considered up to 3 (three) days after the end of the Run. After this time the results of the Run become official results.
  12. During the Run and accompanying events, a photographic and video report will be done. The parent/guardian of the Run Participant agrees to the use of image and processing of personal data of yourself and the Run Participant. Refusal of consent prevents the Participant from registering and participating in the Run.
  13. The Organiser reserves the right, and the parent/guardian of the Run Participant agrees to conduct with each parent/guardian of the Run Participant and with each Participant Running interviews, taking photos and filming for advertising, promotion, use these materials on the Internet or radio and television broadcasts and for other commercial purposes.
  14. The Organiser reserves the right, and the parent/guardian of the Run Participant agrees to free worldwide use of all photos, film materials, interviews and sound recordings of the participants' parents/guardians, as well as Participants of the Run. They may be used by the Organiser by placing on CD, DVD, in catalogues and media, on websites, in newspapers and on exhibitions, as well as for promotional and advertising needs related to the Organiser.
  15. It is forbidden to bring to the place of the Run by the Run Participants, fans and accompanying persons narcotics, illegal performance enhancing substances and alcohol.
- Participants are prohibited from taking such drugs and substances both before and during the run under threat of exclusion, ineligibility and disqualification.

16. The organiser is not responsible for things lost during the event.
17. Only Participants with a bib number may be on the route during the Run placed in a visible place on the chest. Participants without bib numbers and accompanying persons on bicycles, rollerblades, skateboards and other mechanical vehicles will be removed from the route.
18. For safety reasons, it is forbidden to bring on the route, the area around the start and finish of the Run objects that may pose a danger to other Participants or fans and persons accompanying persons.
19. It is forbidden to participate in the Run in clothing that covers the face and prevents identification of participants.
20. If the Race is postponed not due to the fault of the Organiser, but due to force majeure, to another date Participants as part of the fee may start the Run at the specified new date, as part of the paid entry fee. The new date of the Run will be announced no later than in 30 (thirty) days from the date of notification of the need to reschedule the Run. In such a case, resignation from the Run and refund of funds is entitled at the request of the Participant in accordance with the rules set out in paragraph 23 below.
21. Due to the change of the date of the Event due to the holding of local government elections on April 7, 2024, a Participant who has already paid the entry fee has the right, within two weeks from the date of announcement of the change in the regulations of the date of the Run, to resign from participation in the Run and request a refund of the entry fee paid. Resignation from the Run and refund shall be granted upon request of the Participant in accordance with the rules set forth in paragraph 23 below.
22. For the participants of the Run there will be parking (free and extra paid) – access from Al. Unii Lubelskiej in Łódź.
23. The Organiser reserves the right to amend the Regulations no later than April 1, 2024. Any amendment to the Regulations will be posted on the website with an indication of the initial effective date, no later than April 1, 2024, at least 14 days in advance. A participant who does not accept the change in the rules and regulations has the right to resign from the Run within 14 (fourteen) days from the initial effective date of the change. Resignation from participation in the Run, together with indication of the bank account number for reimbursement of the participation fee, should be sent by registered mail with return receipt to the following address: Stowarzyszenie „Maraton Dbam o Zdrowie”, ul. Zbąszyńska 3, 91-342 Łódź or electronically to the e-mail address: stowarzyszenie@pelion.eu. In case of resignation from participation in the Run for the reasons indicated above, the Organiser shall return the participation fee to the participant no later than within 14 (fourteen) days from the date of delivery of the participant's statement of resignation from participation in the Run. Purely technical and organisational changes, including changes in limits, times, number of participants or opening hours of the Run competition office shall not constitute a change to the Regulations entitling to a refund of the entry fee paid.
